Directions:

From I-85: Take exit 78. Get on Hwy. 221 and take Hwy. 176 to Country Club Rd. Turn right on Country Club Rd. Turn left at the light (Hwy. 56). Stay on Hwy. 56, turn left onto Dairy Ridge Rd. and follow signs.

From I-26 Eastbound: Take exit 22, go east on Hwy. 296. for approximately one mile, turn onto Hwy. 295 until it intersects with Hwy 56. Turn right onto Hwy. 56, then take a left at Dairy Ridge Rd. & follow signs.

From I-26 Westbound: Take exit #52 onto Hwy 56. Go N for 30 mi. Turn rt onto Dairy Ridge Rd. Follow signs.

Divisions: Field Hunter & Trail Rider Division. Trails Marked and Safe

Award: First - Sixth place ribbons in each division & points toward WCHPace Series Year End Awards. Groups limited to 4.

Attire: Protective Headgear with harness. NO EXCEPTIONS. Comfortable riding attire.

Assumption or Risk and Release

In consideration of receiving permission to participate in or observe horseback riding or other equine activities and in further consideration of receiving permission to enter upon the premises of the Cannon Equine property or other premises upon which the equestrian activity may be conducted, the undersigned on his or her own behalf and as parent and/or guardian acting on behalf of any minor listed below hereby forever releases, acquits, discharges and agrees to hold harmless Cannon Equine or it's Owners, Officers, Directors, Members, Employees, Guests or any Landowners, or other persons making property available for the Cannon Equine and any of their related companies, any owners of horses located on the premises on which the equine activities occur, of and from any and all liabilities, claims, loss, damage, illness, injury, or death to me that may be sustained by any or each of the undersigned while in, on, or upon the premises of Cannon Equine while participating in or observing the equine activities.

The undersigned acknowledges that there are certain risks inherent in participation in equine activities including (I) the propensity of an equine to behave in dangerous ways that may result in injury to the participant: (II) the inability to predict an equine's reaction to sound, movements, objects, persons, or animals: (III) the possibility of equipment failure and (IV) hazards of surface or subsurface conditions, and notwithstanding these risks, the undersigned desires to engage in or observe equine activities at Cannon Equine and assumes any risk of loss or injury arising from such activity, even loss or injury resulting from the negligence of Cannon Equine. I also agree if anyone makes any claims because of any injury to me (including death) or for any damage to my property, I will indemnify and hold harmless all those releases by this agreement for all damages, losses and expenses including attorney fees.

WARNING

Under South Carolina law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in an equine activity resulting from an inherent risk of equine activity, pursuant to Article 7, Chapter 9 of Title 47, Code of Laws of South Carolina, 1976.
