We are very excited to be opening Biltmore's West Range for this Hunter Pace. Not usually open to the public, the West Range is the 3,000 acres of Biltmore Estate located on the West side of the French Broad (just across the river from Biltmore Equestrian Center). Riders will enjoy the same great views of Biltmore House and the French Broad River as well as scenic trails through Biltmore's Vineyards and farm land.

**This pace will begin at Biltmore Equestrian Center (on the East Side) and proceed over the French Broad River to the West Range.**

**Time:** 9:00AM – 2:00PM

**Entry Fee:** \$45; Youth riders 16 & under \$30 with paying adult; Mother's Day Special! Mothers riding with their child(ren) receive a \$15 discount ("children" can be adult children)

**Lunch:** Included in entry; sandwich buffet served from 11:30am-2:00pm. Lunch for non-riders \$15.

**Registration:** Riders must call BEC office at (828) 225-1454 prior to May 13th to submit their name for the gate list. Participants may be held at Lodge Gate if not on the gate list.

**Awards:** Ribbons through 6<sup>th</sup> place in both divisions; points toward Western Carolina Hunter Pace Series.

The undersigned acknowledges that there are certain risks inherent in participation in equine activities including (i) the propensity of an equine to behave in dangerous ways that may result in injury to the participant: (ii) the inability to predict an equine's reaction to sound, movements, objects, persons, or animals: (iii) the possibility of equipment failure and (iv) hazards of surface or subsurface conditions, and notwithstanding these risks, the undersigned desires to engage in or observe equine activities at Biltmore and assumes any risk of loss or injury arising from such activity, even loss or injury resulting from the negligence of Biltmore other than gross negligence or wanton or willful misconduct.
